# Rector's Reflections on 2015 - Sunday Service-goer or Daily Disciple?

"We rejoice and give thanks to God for many exciting new developments in our churches. In Saint Paul's we have been stimulated by our monthly series of Evensong with Discussion, and grown in fellowship through our Wednesday Coffee, Chat and Cake; in Holy Trinity we have blessed the community of North Bushey with Hot Chocolates, Family Films and Tiddlers; in Saint James's our pre-school and primary school aged worshippers have joined together for fun in Fireworks, and a number of adult members (new and more established) have grown together in faith in Pilgrim discipleship groups; parish-wide we have been supporting those most in need through our Pastoral Visitors scheme. However, there is much work still to do. "

The above words prefaced a document that the PCC issued in the Autumn of 2015 outlining a refocussing of both priorities and models of working for 2016. With "discipleship" running through the heart of everything (rather like the indelible letters in a stick of rock), the PCC took a decision to try and bring about a new culture and context in which to place our common life. This was in turn endorsed by all three church committees. But there are some who felt that we were imposing a rather strict and rigorous attitude on the way some things worked. Not everyone likes working as part of a team (or, rather, whilst some are happy to be team leaders, not all are happy to be team members!). For those starting out in whatever career today, "team-work" is an essential, not an option. And so it must be for us if we are to be a church pulling in the same direction.

Whilst a Rector's report should quite rightly celebrate achievements and successes for the year, and indeed point to challenges ahead, it must also be honest. At St. James's there have been a number of different things which have challenged our resilience during the course of 2015. We said farewell to no less than 15 regulars who have moved to other parts of the country (or world!). This has inevitably had an impact on our worshipping numbers, and indeed our planned giving (CMF) as without planned giving there would be no church here in the first place! Also, as a result of what some outside the church have referred to as "internal politics" we saw a series of events which led to the St. James' Church Flower Guild become independent of the church; at the same time, we saw the creation of a new St. James's Church Flowers Team which is gaining in confidence and numbers. I would like to place on record my sincere thanks to members of the St. James's Church Flower Guild for all they have done over some 40 plus years to enable us to worship God in the beauty of holiness. It was also sad that, as a result of these "internal politics" we lost a few members of our worshipping community. We continue to pray for God's healing hand to be upon that situation and pray that those who have found new spiritual homes may know God's peace as they engage in worship elsewhere.

If church life mirrors family life, then 2015 has seen not just some "downs" but some "ups" too as I mentioned at the start of this report. We thank God that we have seen some absolutely amazing signs of real discipleship and spiritual growth taking place. The Discipleship Group which began in Autumn 2014 embarked upon a second year, something we never imagined would happen; and a new group is planned for 2016. So whilst we have had some difficult moments in 2015 I hope these may be eased a little by so many encouraging signs of spiritual growth in our three churches. After all, it's the spiritual growth which turns people from being Sunday Service-goers into Daily Disciples.

Perhaps the words of the Easter blessing might encourage us - they are certainly my prayer as I thank God for the joys and sorrows of 2015....

Finally, I thank God for the privilege of being your Rector and offer my sincere thanks to all those who support me in this task in so many varied ways. I feel truly blessed to be your Parish Priest.

#### Structure, Management and Governance

The Parochial Church Council (PCC) is a body corporate established by the Church of England. The Ecclesiastical Parish of Bushey operates under the Parochial Church Council (Powers) Measure 1956

The PCC is registered with the Charity Commission, number 1130540.

The method of appointment of PCC members is set out in the Church Representation Rules. All those who attend our services are encouraged to register on the Electoral Roll and to stand for election to the PCC. PCC meetings are all public meetings and all members of the congregation are invited to attend. The PCC held eight meetings during the year, which included an Away-Day. Members are welcomed to attend at all PCC meetings, but do not have a vote. Issues raised for action at PCC meetings included:

- Living God's Love the Diocesan initiative.
- The Mission Plan was further developed.
- Arrangements for the annual update of the Safeguarding policy and procedures.
- A strategic document was produced outlining a future pattern for working more collaboratively both within the individual churches as well as the parish as a whole.
- Updating of the Health and Safety Policy and the initiation of asbestos checks in Parish property
- Initiation of a review of properties (other than the three churches) to determine structural soundness, potential repair costs, and the appropriateness of their relationship to the mission of the Parish.
- The summary of the Sustainability Group presented March 2015.
- Reports from the PCC sub committees listed below have been received and considered regularly at PCC meetings.

## 2. Planning and development of fundraising activities

A programme of summer lunchtime recitals were good occasions and successful 'fund-raisers' as well as drawing together the wider community.

# 2015 Reports

Ministry, Worship and Service Reports

#### **REPORT FOR ST. JAMES'S CHURCH 2015**

In 2015 St. James' Church has seen another year of encouraging growth in all aspects of Church life. Attendances on Sunday mornings have seen an increase in numbers, with new friends and families worshiping with us. It has been good to see the Church growing and moving forward.

#### **CLERGY AND SERVICES**

The last year saw the Ministry Team grow even more when we welcomed Joe Palfreyman as a Youth Worker mainly working with Holy Trinity but we have seen Joe with us also, working alongside Father Graham. We continually pray for Father Neil and give thanks for his commitment to the Church and its parishioners, and all his hard work behind the scenes both day and night!

First Sunday of each month is All Age Eucharist followed by coffee and croissants, other Sundays are normal Services except the 3<sup>rd</sup>. Sunday when there is an opportunity to receive prayer for healing following Communion. Little Sparks (formerly Crèche) and Lighthouse meet at 9.30 a.m. in Church and then go to their own teaching facilities in Church House. For those involved this means regular commitment in preparation, setting up and leading and also co-operation with those who use Church House for Parish Breakfast.

The Church was blessed with an Away Day with 41 members of the St. James's congregation attending. The Mission Action Plan was an out-come of meeting together.

#### **OUTREACH AND EVENTS**

Events throughout 2015 included Tots Praise, the Art Exhibition by St. Margaret's School, Summer Recitals, being part of the Parish Summer Fair, Friday Night Youth Club, Christmas Card Drop, Christmas Fair and other social events. Some of the Clergy are Governors of local Schools and lead Assemblies which helps to maintain contact with the community. We give thanks and recognise all of these events which reach out to people in the Parish. Our events happen because of the commitment of volunteers who give their time and talents freely.

The Rectory became the focus of a low-key food bank for the needy of the Parish.

#### **CHURCH BELLS**

The fantastic amount of finance that was required to repair and rehang the bells was forthcoming to enable the project to begin. This was a big Church effort but also came about because of the generous support and interest from the community. It was indeed great to see the bells returning in the autumn and the bells being blessed by Father Graham before they were rehung. We were overjoyed to hear the test ring and then to have, once more, the peal sounding around Bushey Village especially for Christmas and New Year Services.

#### **CHURCH BUILDINGS**

Thanks are extended to all those who continually help voluntarily with repairs, maintenance and cleaning, which not only enhances the buildings but build relationships with those who are working together in a practical way. We have once more benefitted from finance accrued from the filming of the television series EastEnders. Church House has become more viable with the significant increase in bookings and social events for the Parish and St. James's community since Joanna Hewitt became Bookings Manager. And we give special thanks to all those who gave time and effort to the refurbishment of the Hall and The Lucy Kemp-Welch Gallery.

#### SERVICE TO THE COMMUNITY

St. James's Church continues to offer help, comfort and blessing to those needing the facility of the Church for Funerals, Internment of Ashes, Weddings and Baptisms.

## ST. JAMES'S CHURCH FLOWERS TEAM

This new group came into existence in November 2015 and their very first assignment was the provision of flowers for the Christmas celebration which focused on the various "stations of the nativity". We are open to men, women and children of all ages! No experience is necessary—just enthusiasm and a desire to help use flowers and other materials to enhance our Worship of God.

#### **REPORT FOR ST. PAUL'S CHURCH 2015**

<u>Events</u>: St. Paul's ran its usual 7 **jumble sales** in 2015, raising £300-£400 each time. They give the local community a chance to meet up for a chat over light refreshments, and draw in good quality items for our Christmas Fair and Wednesday 'bargain table'. St. Paul's began to have the church open on 'jumble sale' Saturdays; a rota is now in place to have a member of the clergy present in church during 2016. Once again, our **Christmas Fair** was very well-supported both in terms of volunteer helpers, and attendees. It has built a great reputation over the years, shamelessly using the same formula and, in 2015, raised a record £3,000.

During the year, St. Paul's held two **special lunches**, plus a Quiz & Curry evening in aid of ABF The Soldiers' Charity. Cooking a 3-course meal in our tiny kitchen presents its problems but the evening was a great success and raised around £900 for the charity.

The 20th season of **St Paul's Proms** consisted of 7 concerts in spring and autumn. The standard format is: 3pm start, free entry, retiring collections for a range of charities, tea & cake or cookies to follow. We are fortunate that so many musicians are willing to donate their time and talents, and give such a high standard of performance. For the second time, we included a spoken-word event, with great success.

During the year, St. Paul's began to open its doors on Wednesdays, 10.00am ~ 12 noon, for **coffee, cake & chat**. The main body of the church is easily adapted to serve as a café-style venue and the mornings now attract 15 - 30 folk, swapping books, doing jigsaw puzzles and browsing the 'bargain table'. Mostly, though, people just chat! Although there's no charge, the donation plate, together with the bargain table, means that these mornings are self-funding.

St Paul's is grateful for the additional support now offered by members of St James's Church for both the St Paul's Proms and the Wednesday Coffee & Cake mornings.

After the Wednesday coffee mornings, a short service takes place at 12.30 (usually a Eucharist) in the newly de-cluttered chancel area and this is proving noticeably more popular than our previous mid-week service held on a Wednesday evening.

John Stobbart Hall: St. Paul's hall continues to be hired by the nursery school Bush-e-Babes, throughout the week. It was decided that renting the hall on Sundays presented too many problems and it is now advertised for hire on Saturdays only. The hall is very much in demand, is rented most Saturdays for children's parties and continues to be an excellent source of income. We're extremely grateful to Margaret & Derek Shaw who keep the hall clean and carry out small maintenance tasks.

#### **REPORT FOR HOLY TRINITY CHURCH 2015**

This last year God called us as a church into a year of blessing our community. Blessing started in a small way with the giving away of hot chocolates to parent, carers and children after school. The idea came from Joe and the Soul61's and not even they with all their enthusiasm and vision could they imagine where it would lead us as a church.

As we have tried to stay faithful through the year to this calling to bless the local community, we have been so fortunate to see the fruit of this obedience. It wasn't long before a few people taking hot chocolates, turned into lots of people taking hot chocolates to us building relationships with many people from the local community we had no contact with previously.

Fundraising socials started popping up all over the place and it was amazing to see that you could feed 80 people a three course Burn's night supper from a small domestic cooker in a cramped kitchen. Well done Jennie and team. It was lovely that we were joined by so many other Christians from across Bushey at our events and we are grateful for their encouragement and participation.

By the time Easter came we were serving well over 100 people from the local community a cup of hot chocolate each week. Soon people started to have visions and dreams of other ways we could bless the local community. Tiddlers our Mum's and Toddlers group started followed by a regular weekly youth group. The summer saw an incredible community fair on the green just down from Holy Trinity which was a huge success. In the Autumn we continued to find ways to bless the local community with a club for year 5 and 6 children, Sunday Live service, going door to door praying for people and finishing the year of blessing off by starting our Trinity Tuesday's Lunch and club.

We are so much richer individually and corporately for our new friends. We cannot imagine doing life as Holy Trinity without the children, young people, families and people we have met in the local community. We have been truly blessed as we have tried to bless, and have discovered as a church afresh the wonder of Jesus' kingdom coming on earth as it is in heaven.

We have been encouraged again and again throughout the year as people have shared during our services testimonies of a loving God providing and caring for his children. Stories of miraculous healing, financial provision, guidance, restoration and love continue to inspire us. We long for many more because we love the fact that our God is able to so much more than we can ever ask or imagine.

There is so much more we could say, like how proud we are of Anne Underwood's Ordination in the summer and ministering Jesus love amongst us or of David Hibbert making his vision of a lunch club to reach the vulnerable a reality. But our reflection as we finish this snapshot of a year at Holy Trinity is to remind ourselves and to let you know of our purpose which is to be a place and a group of disciples that live out the invitation from Psalm 34 to 'Come, taste and see that the Lord is good'.

## WATFORD DEANERY SYNOD - Report on 2015 - for 2016 APCM

Four meetings were held during the calendar year 2015:

- Tue. 27<sup>th</sup> Jan ~ an open meeting at St Paul's School, Langleybury, at which John Kiddle led us in thought and discussion on issues around what we understand when we talk about growth, vision and the value of growth.
- Thu. 19<sup>th</sup> Mar ~ St Andrew's, Church Road, Watford; Kathryn Alford, the Diocesan Vision Development Enabler, led us in reflecting on, renewing and re-energising 'Living God's Love'.
- Wed. 20<sup>th</sup> May ~ Soul Survivor, Watford
- Wed. 25<sup>th</sup> Nov ~ an open meeting at St Mark's Church, Leggatts Way; the Bishop of Hertford, the Rt Revd Michael Beasley, gave a broad picture of 'Living God's Love 2020' (the Diocesan Vision for the next five years) and the Revd Jeanette Gosney, Parish Development Officer, then focussed on the 'Lay Ministry Strategy towards more intentional discipleship'. There was an opportunity to ask questions.

Since the year end, a meeting was held on 4 February 2016, at All Saints, Leavesden, at which Tim Roberts, Senior Minister at Wellspring Church in Watford told us about the initial steps towards 'Continuous Prayer Response' and also spoke about the exciting ecumenical work of 'Christians Across Watford'.

All meetings include reports from Diocesan Synod and General Synod, where relevant, and also Rural Dean's Notices. The meetings also include an informal act of worship.

† The post of Deanery Secretary has remained vacant since late 2014. Should you be interested in supporting this part of the church's work, Christine Cocks, amongst other Deanery Synod reps, has a copy of a 'flyer', with a brief job description of the unpaid post of Watford Deanery Synod Secretary. It's estimated that, along with eight meetings per year, it involves about 2-3 hours/month; access to a computer is essential.

#### **Home Communions.**

Many people as they get older or as they suffer increasing disability are unable to physically get to a church building. However, for their continuing spiritual life and growth, they value the opportunity to take Communion on a regular basis. Members of the laity and the clergy carry out this ministry to the housebound.

About ten people are involved in this ministry taking communion to 14 to 16 people every month. This ministry includes visiting Bushey Beaumont and other residential homes in the area. At Bushey Beaumont, two or three members of the congregation join in with the residents giving it a real feel of 'the Church going into the Community'

In Peter's first letter Chapter 2 verse 6 "and like living stones, let yourselves be built into a spiritual house, to be a holy priesthood, to offer spiritual sacrifices acceptable to God through Jesus Christ." And so as we are all part of the priesthood of all believers, being involved in Home communions is part of everyone's ministry as we all pray for all those involved. If you think that you are being called to this ministry and would like to explore it further please have a word with Fr. Neil.

#### **Pastoral Visitors**

Fr. Neil, when he first approached me to consider joining the team here at Bushey, was interested to hear about the Pastoral Visiting Team I had been involved in setting up at All Saints, Croxley Green.

The clergy here in Bushey took prayerful time to consider who would be suitable pastoral visitors and also have the time to be involved in this ministry. We held a social evening with members of the team from All Saints', so experiences could be shared. The course ran during the spring of 2015, at St Pauls' on a Tuesday morning.

The Course.

The course was no easy 'walk through the park'. It was five weekly two-hour sessions. It also required the participants to do some preparation for each session and some post-session reflections. These reflections were submitted to Rev Jeanette Gosney (the Diocesan Parish Development Officer and the author of the course) for her confidential comments.

The content of the course involved such topics as praying with people, listening and sharing, confidentiality issues and the setting of boundaries. There was also an emphasis on the development of practical skills. Verity Harvey and I jointly ran the course and we gained a great deal of experience while leading course. We were all supported by prayer and by coffee and cake! Individuals who had submitted their reflections to Rev Jeanette, gained a Diocesan award. These were presented in the autumn of 2015.

The Visitors and Visiting.

As we are all becoming increasingly aware, the role of the clergy is changing dramatically. No longer do they have the time to do all the parish visiting which is necessary in a busy parish community, especially when other support systems, like adequate time with one's GP or time with mates down the pub are decreasing. So the importance of a lay pastoral team is vitally important. The referrals come via the clergy and great care is taking to match up the visitor and visitee. Visits take place about every 4 weeks and occasionally Home Communion is an important part of the visit. However not all member of the PV team are home communion administrants, and not all home communion administrants are Pastoral Visitors. Please pray for the members of the team as they are involved in this real outworking of "Living God's Love" in the aspect of Transforming Communities.

#### **Baptism Preparation Group Report**

Outreach and Pioneer Ministry Reports

#### Hot chocolates

Over 2015 hot chocolate ministry went from strength to strength. As the months went by we persisted in getting ourselves out into the community week after week come rain or shine. We saw such positive outcomes in the surrounding area that we have now decided to clone the project doing the same initiative from St Pauls on Bushey hall road, as of Christmas 2015 we were giving out between 35 - 50 hot chocolates every Monday between 3:00pm - 5:00pm with the hope of starting a Youth@SP club in the not too distant future. In 2015, the three churches and clergy CMF contributed £130,228 towards Parish expenses of which £118,061.80 was paid to the Diocese as our Parish Share. A total of £84,542.48 was given by CMF members.

Children and Young People

#### Lighthouse

Lighthouse and Little Sparks are our primary-school and pre-school children's worship groups. Attendances at both vary hugely from week to week, as parents juggle many other Sunday-based activities and events. Weekly attendance at Lighthouse, for example, can number from as few as 4 to as many as 15 children, with an increasingly diverse age range, which can make resourcing and planning a challenge!

## Over the year we have:

- Reconfigured Little Sparks to be more a pre-school 'worship' area rather than a play area. This area now looks much more welcoming, with hand-made liturgy books and bags, and Bible related toys and equipment which attempt to allow parents and guardians to engage with their child during the worship. Unfortunately because of numbers we can no longer have an additional 'helper' offering an extra pair of hands to any parents who need assistance. If anyone would like to volunteer to help out with Little Sparks, please let Fr Graham know.
- Moved Lighthouse over to Church House, giving more space but requiring an increasing level of staffing more volunteers are needed to ensure Lighthouse provision can continue to grow and develop.
- Along with volunteers in other roles, Lighthouse helpers participated in Safeguarding training.
- The 4th Sunday 'Noisy and Messy' has been rebranded 'Fireworks'. This meets in Church House and is for both Lighthouse and Little Sparks children present with their parents). The aim is for Fireworks to operate as a worship space for our young people, rather than a 'School'. Fireworks has recently started a program looking at 'Saints and Psalms'.
- The age discrepancies in Lighthouse children is continuing to become more and more pronounced. If we are to effectively engage with the younger members of our congregation, and grow and develop their faith and spirituality, we must resolve this. Unfortunately at the moment, we do not have the volunteers to be able to stream the groups by ages.

#### Little Sparks 2015

During the year, Little Sparks has developed as a great place for parents to worship with their babies, toddlers and preschoolers. There have been a range of resources produced, especially fabric liturgy bags, books and fuzzy felt, which have helped children and adults to engage with the services together. More Christian books and jigsaws have also helped them to start to learn some of the stories that I hope will be with them for the rest of their life. Many thanks to all who produced these, especially Vicki. Joint monthly activities with lighthouse have been a lot of fun as well and a chance to run around! It can be a real challenge to get young children to engage with worship, but I have found it really helpful to have lots of support for this from so many at St James, both for the times when they are running round noisily, as well as those lovely (rare) times when they seem to 'get it'.

## **Tiddlers at Holy Trinity**

We are approaching our first birthday at Tiddlers, held at Holy Trinity on a Wednesday morning, and what an amazing year it has been. Each week has a different theme (ranging from 'People who help us', to 'Superheroes', 'Musical instruments' to 'A teddy bears' picnic') and we have a large selection of toys that have been donated that we rotate weekly, alongside a craft (favourites have included autumn leaf collages, stamping letters to post in our post office, and penguins from toilet roll tubes), a table for mark making (chalk boards, sand trays, paint bags etc), and a playdough table (with coloured/sparkly playdough and cutters or mats or things to stick in). The first hour is free play where the children choose what they want to do, and to add a bit of variety, we bring out a messy play activity (fake snow, earth, shaving foam etc) half an hour in. The children are then encouraged to help pack all the toys/activities away, before sitting down together for healthy snack time (although the regular provision of cake for the mums is less healthy!). We finish with a story and song time gathered on the mats and beanbags before we say goodbye.

The numbers of mums with toddlers and babies attending has steadily grown and we regularly have around 20-25 little ones with a few extra babes in arms. Everyone that attends tells us how welcome they feel regardless of their faith or upbringing and lots of new friendships have formed between the mums who attend the group. It has even encouraged some families to attend our worship and had led to one of the toddlers being baptised. Most of the mums are open to being prayed for and we hope this is the first steps towards showing them God's love.

#### Club 56

Club56 is a Friday after school club run for children in school years 5 and 6 (Ages 9-11) from 5pm till 6.15pm. It started in October, and in that time has grown so that (at time of writing in early February) the last few sessions have had 5 attendees, which is very encouraging. Each session starts free time, where they can choose between painting their nails, playing games on the Wii and Xbox or a craft. It then moves into a group game, followed by a bible story, which often includes one or more children demonstrating their acting skills, and then a discussion helping the children see how the bible story can be applied to their lives. It offers the children who come an opportunity to engage with the Bible in a manner accessible to people their age. We're also blessed with a few members of Youth Club who stick around to help, enabling them to be released into leadership roles. These young people aren't Christians themselves, so we're also providing an extra environment for them to learn about Christianity.

### Youth@HT

In 2015 we saw huge growth in our youth work mainly due to the quality of relationship built between the team at Holy Trinity and the young people we met week in week out at our free hot chocolate giveaway. We now run Youth@HT every Friday of term between 3:00pm - 5:00pm. A typical session consists of our young people arriving and spending time playing group games, sports, video games, doing crafts and other activities with fellow young people and the team. We have been focussing on the relational aspect of these session for the past months, our aim to simply have fun and get to know the group well. The outcome of this time which we have invested in relationship is to begin conversation slots within the youth club where we come together as a group and talk about current issues and life, with the ultimate aim of bringing a Christian perspective of the issues to our young people so that they will learn what it is Christianity is all about.

Buildings and building for our future

Since the decision of the PCC in 2015 to sell both Trinity House and Falconer Hall as they were surplus to requirements, the Sustainability Implementation Group has been working to implement the decision of the PCC.

Trinity House was given priority as it did not depend on the formation of a trust to purchase the property, as in the case of Falconer Hall. We were on course to commence formal sales negotiations with Pineridge Housing Association at the end of 2015, as directed by the PCC. However, a last minute legal intervention regarding compliance with s119 of the Charities Act 2011 meant that a decision had to be taken to place the property on the open market to demonstrate that best value had been achieved. Following a marketing campaign in January 2016, four offers were received of which the PCC decided it had no option but to accept the highest as it exceeded all other offers by a large margin. Currently, we are proceeding to exchange of contracts.

Meanwhile, we have been negotiating with the Bushey Village Community Hall Trust to allow them to purchase the Hall at a price which could be well below the market level for the benefit of current and future community users. However, in the light of our experience with the sale of Trinity House, we sought further guidance from our legal and survey advisors to confirm the best course to follow with the sale of the Hall.

## **Buildings Group**

The Buildings Group meets monthly and is responsible for overseeing the upkeep of the fabric of the three churches.

All three churches were subject to the Quinquennial inspection earlier on in year. The Church of England's Quinquennial inspection system provides for the inspection of church buildings every five years by an architect or chartered building surveyor.

The Quinquennial report is one of the key documents which assist the Parochial Church Council (PCC) in the care and repair of a church building, for which it is legally responsible. It gives a snapshot of the repair needs of the building, and lists the repairs required according to their priority.

The reports were received and discussed at the Buildings Group. The Buildings Group have drafted a programme of works and a report went to the PCC on 10<sup>th</sup> November 2015 recommending that the PCC make provision in the 2016 budget for the works required. This was agreed. In the last year the Buildings group have overseen works to repair roof leaks at St James Church to the vestry and the area at the rear of the church. Roof repairs have also taken place to the tower roof where there was considerable water ingress.

At St Pauls a parking space has been made at the front of the church and concrete posts have been fitted on the bend in the road to the rear of the church to prevent vehicles missing the bend.

I would like to thank the group for the work they have carried out this year.

#### Falconer Hall Management Group

Joanna Hewitt - Chair, Sue Baxter - Secretary, John Wray, Jessie Clack, Roy Golding, Marcus Cox, Fr Neil Kelley.

The Management Committee undertake the day to day running of the Hall and meet 6 times a year to review activity. Hall bookings, associated invoicing and collection of fees is undertaken by Jessie Clack and the ongoing day to day maintenance and cleaning is overseen by John Wray.

Rental income for the year, 2015 increased from 2014 to £17,347.32. Expenditure for the year, including day to day repairs, with no major capital projects being undertaken in the year, utilities, cleaning and insurance totalled £13,581.04 resulting in a net income figure of £3,766.28 for the year.

The Hall is regularly used by 3 main hirers St James's Music and Drama Group, 7th Bushey & Oxhey Scout Group and Startright Pre-school/Buzykidz, who also run Breakfast and After School Clubs in the main hall. Other regular users include Zumba classes, Ballet classes and Badminton group. In addition the hall is let on an ad hoc basis for parties and meetings of various community groups such as the Bushey Horticultural Society.

During the early part of 2015 a full Sustainability Report was carried out looking at the current state of all non-church buildings. As a result of this we were told by the Diocesan Surveyors (Rumball Sedgewick) that over a period of time somewhere in the region of £178,000 - £238,000 would need to be spent on the hall to make it fit for purpose for the future generation of users. Following a decision of the PCC in March to sell Falconer Hall, a group of current hall users has been formed called the Bushey Village Community Hall Trust, with the purpose of exploring purchase of the Hall. This group came into existence following an open meeting held in Falconer Hall on 23<sup>rd</sup> June.

In November, John Wray reported that whilst the CIO 'Bushey Village Community Hall' had been formed it was still awaiting formal registration by the Charity Commission. A draft business plan was submitted to the PCC in the autumn.

## Parish Finance Officer's Report for 2015

2015 proved to be an atypical year for the Parish. On the plus side, as a result of a successful appeal, the bells of St James the Apostle were rehung and fully restored in a new frame and fittings. After removal of the bells, the work needed to strengthen the tower was much greater than anticipated and we had to draw on reserves to cover the cost of this work.

The sale of Trinity House, designed to fund our Mission work and to make our buildings fit for purpose took longer than anticipated and was not achieved in 2015. Reserves were again needed to fund various mission projects especially the appointment of a Youth Worker and Families Worker. It is pleasing to note that Unrestricted income from donations and legacies was £23,209 greater in 2015 compared with 2014 although our expenditure was greater due to increased activities and mission work.

Although we paid our Parish Share to the Diocese in full not all the churches were able to meet the GPE target set in the budget. Although some of our members increased their giving to a more realistic amount, many did not. We need to review our giving and encourage all who are on the Electoral Roll to join our planned giving scheme (CMF) if they haven't already signed up as members. We did recruit several new members in 2015 but we also had people who moved away because of work or retirement.

At the direction of the Extra Parish meeting the PCC will request the Charity Commission to endorse payments to Vicki Adamson (Church House cleaner) and Stuart Brant (Director of Music, St. James's) as these are both "connected persons" (that is, they are married to a Charity Trustee/PCC member).

Notes to the Accounts for the Year ended 31 December 2015

#### I. Accounting Policies

"The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard for Smaller Entities published on 16/07/14, the Financial Reporting Standard for Smaller entities (effective January 2015), the Church Accounting Regulations 2006 and the Charities Act 2011.

The accounts (financial statements) have been prepared to give a 'true and fair' view and have departed from the Charities (Accounts and Reports) Regulations 2008 only to the extent required to provide a 'true and fair view'. This departure has involved following the Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard for Smaller Entities published on 16 July 2014 rather than the Accounting and Reporting by Charities: Statement of Recommended Practice effective from 1 April 2015 which has since been withdrawn.

The financial statements have been prepared under the historical cost convention except for the valuation of investment assets, which are shown at market value. The financial statements include all transactions, assets and liabilities for which the PCC is responsible in law. They do not include the accounts of church groups that owe their main affiliation to another body nor do they include groups that are informal gatherings of church members."

#### 2. Funds

General funds represent the funds of the PCC that are not subject to any restrictions regarding their use and are available for application on the general purposes of the PCC. Funds designated for a particular purpose by the PCC are also unrestricted.

Restricted funds are those funds that must be spent on restricted purposes and details of the funds held and restrictions are provided in note 8. Endowment funds, where the capital must be retained, are also explained in note 8.

#### 3. Incoming Resources

Voluntary income

Collections are recognized when received by or on behalf of the PCC. Planned giving receivable under Gift Aid is recognised only when received. Tax recoverable on Gift Aid donations is recognised when the donation is recognised. Grants and legacies to the PCC are accounted for as soon as the PCC is notified of its legal entitlement, the amount due is quantifiable and its ultimate receipt by the PCC is reasonably certain. Funds raised by fund raising events are accounted for gross.

Other income

Rental income from the letting of church premises is recognised when the rental is due.

Income from investments

Dividends are accounted for when due and payable. Interest entitlements are accounted for when receivable. Tax recoverable on such income is recognised in the same accounting year.

Gains and losses on investments

Realised gains or losses are recognised when investments are sold. Unrealised gains or losses are accounted for on revaluation of investments at 31 December.

#### 4. Resources Used

#### Grants

Grants and donations are accounted for when paid over, or when awarded, if that award creates a binding obligation on the PCC.

Activities directly relating to the work of the Church

The Diocesan parish share is accounted for when due. Any parish share unpaid at 31 December is provided for in these accounts as an operational (though not a legal) liability and is shown as a creditor in the Balance Sheet.

Costs of generating funds include the cost of stewardship campaigns, investment management costs and costs relating to rental properties. Charitable activities comprise the costs relating to the work of the parish. Governance costs represent the costs of running the PCC as a legal entity and include the costs of preparation and independent examination of the accounts.

#### 5. Fixed assets

Consecrated property and movable church furnishings

Consecrated and beneficed property of any kind is excluded from the accounts by \$10(2)(a) of the Charities Act 2011.

Movable church furnishings held by the Vicar and Churchwardens on special trust for the PCC, and which require a faculty for disposal, are accounted as inalienable property unless consecrated. They are listed in the church's Inventory which can be inspected at any reasonable time.

All expenditure incurred in the year on consecrated or beneficed buildings, or on individual items under £1,000 is written off.

Land and buildings are shown at cost or at valuation based on 1970 figures.

#### Depreciation

Fixtures and Fittings are depreciated at 10% of cost and Office Equipment is depreciated at 25% of cost. Buildings are depreciated at 2%. However, since the 1970 valuations included the land it is assumed that each contributed 50% to the original valuation such that the effective depreciation is 1% as land does not depreciate.

#### 6. Investments

Investments are valued at market value at 31 December.

#### 7. Current assets

Amounts owing to the PCC at 31 December in respect of fees, rents or other income are shown as debtors less provision for amounts that may prove un-collectable. Short-term deposits include cash held on deposit either with the Central Board of Finance of the Church of England Funds or at the bank.

#### 8. Liabilities

Liabilities are recognised when there is a legal or constructive obligation to expend resources.
