The Rector's Reflections

Welcome to the 2016 Annual Report! I'm not really sure where to start when reflecting on 2016. It was a year that saw many exciting and significant things happening. Most memorably, we were honoured to welcome the Countess of Verulam who opened the Flower Festival in St. James's as part of the Bushey Festival. This was a super day and her presence certainly added to the importance of that occasion.

Some months before that the parish had experienced not one, but two Confirmation Services. Holy Trinity welcomed Bishop Alan and St. James's and St. Paul's welcomed Bishop Michael. The last time there were as many confirmations in one year was 1992 in Canon Philip Morgan's time here. Both occasions were memorable and Bishop Michael put his hands to good use that day – he ascended the Ringing Chamber at the end of the Eucharist and blessed the bells – something those of us on the ground watched on the TV screen!

The Red Trust Bushey's work in 2016 saw the work of the Foodbank for Bushey take shape. These included plans for people to come along to St. James's Church House on Friday mornings. At Holy Trinity the pioneering projects continued to grow and take shape, the regular mid-week "Coffee, cake and chat" at St. Paul's sees ever growing numbers of visitors and for many at St. James's a highlight was hosting a Christmas Lunch for any in the community that wished to come along. This attracted a phenomenal amount of volunteers from the wider community, and we look forward to working with some of these people in the coming months.

In the summer of 2016, Fr. Graham began his final full year with us. We have all continued to enjoy the fruits of his ministry, among which have been various opportunities to pray and worship in creative ways, particularly in the seasons of Advent and Lent.

We said farewell to Elena Major and Mel Love who were re-locating due to their husbands' new army postings. However, we welcomed Melanie and Nicola, there relative replacements. Also, due to the increased activity on the financial front, we appointed Deborah Kelly as our new Finance Officer post.

For many, a significant and poignant activity was the sale of Falconer Hall. Letters on file from the 1970s, 1980s and 1990s demonstrate that this possibility has been explored more than once! There have been many things said on this subject so I do not intend to repeat myself. However, we do place on record our gratitude to all those who have used the hall, cared for and maintained the hall over its 125+ years and we look forward to our partnership with the new owners who, like our parish, are committed to serving our community.

With my deep gratitude for all the love, service and commitment shown by so many to our Loving God. May God continue to bless you, those are dear to you, and the work you undertake in His name.

- Community involvement, including the support of local cultural events (music, artistic, etc) and social action (our foodbank, a free Christmas Lunch, Soup & Chat).

Objectives and Activities

- The Parochial Church Council (Powers) Measure 1956 states that the PCC: is to co-operate with the Minister in providing in the ecclesiastical parish the whole Mission of the Church, pastoral, evangelistic, social and ecumenical.
- In the Parish of Bushey we continue to develop within the Diocesan Living God's Love programme which includes deepening spirituality, outreach to the local community, and a Mission Action Plan.
- Our mission continues to be to proclaim the Gospel according to the doctrines and practices of the Church of England. The PCC maintains an overview of worship throughout the parish and assists in the involvement of the many groups that that live within the parish.

Achievements and Performance

- I. Development of opportunities for prayer, reflection and faith sharing.
 - a. Baptism and Marriage preparation provide opportunities for teaching, support and welcome to the church.
 - b. Sunday Schools at St James's (The Lighthouse & Little Sparks), at Holy Trinity (Rock Solid) and Youth Clubs (Club56 and Youth Club) continue to develop and grow.
 - c. Pre-Christmas and pre-Easter workshops for children were held at Holy Trinity and St. James's
 - d. Special Christmas services in each church welcome many families and schools to joyful celebration.
 - e. Regular quiet sessions offer opportunities for the recently bereaved to have a space where they can have peace to reflect.
 - f. A weekly "coffee, cake and chat" operates at St. Paul's which has been very well supported and some stay to share in the Eucharist afterwards
 - g. Lent and Advent Quiet Days have taken place at St. Paul's
 - h. Parish Sunday Evening services include Choral Evensong and Benediction (St James's), Eucharistic Devotions (St. James's) and Sunday Sanctuary – a reflective Taize/Iona style worship (St Paul's), an afternoon service for families once a month (Holy Trinity) and "discussion" Evensong on topical issues monthly (St. Paul's)

2. Planning and development of fundraising activities

Well proven fund raising events - quiz nights, raffles, lunches, suppers, concerts, jumble sales, summer and Christmas sales, stewardship programmes; all provide opportunities to assist with financial support for the parish, and assistance to UK and overseas charities. They also have a social function and draw in members of the local community. A programme of summer lunchtime recitals were good occasions and successful 'fund-raisers' as well as drawing together the wider community.

3. Exploration of Eucharistic and Social Life in ways that lead to growth opportunities.

Lent and other discipleship courses were held across the parish which gave opportunities to learn and worship together in formal and informal settings, and to meet people. Special welcome services and Patronal Festivals and social events are joyful occasions and give opportunities to welcome members of other churches, and our local community.

4. Ecumenical links

Bushey and Oxhey Churches organise a Good Friday service by the Village Green in which the Parish participates. The Week of Prayer for Christian Unity is supported within the Parish. Holy Trinity regularly joins with the other churches in North Bushey for worship, social activities and community involvement.

REPORT FOR ST. JAMES'S CHURCH 2016

2016 has seen good attendance throughout the year. Throughout 2016 a range of Pilgrim and Discipleship courses took place. These were extremely well attended and proved very popular. Feedback is that they were both informative and fun!

Meeting and greeting has been well received by our congregation, by those visiting for the first time. Many of the newcomers are young people and families. The compliments received make our position in the welcome area a worthwhile one and we have noticed many of the younger newcomers have become regulars, also making themselves available where possible to get involved in various areas of the church.

The recital season in 2016 was an overwhelming success, so much so that guest recitalists and the public have asked for a longer season in 2017. Many of the recitalists have asked if they can return for another booking. The comments received by the public have been very favourable they say they are made to feel welcome and are well looked after.

2016 saw an increase in local schools using St James's Church for their Christmas carol concerts. Teacher, staff and parents expressed how well they were assisted and looked after on arrival. It looks as though Christmas 2017 could be even busier

We were honoured to be asked by Hertsmere to host the Annual Civic Service and this took place in October.

In June this year, we were delighted to welcome Michael, Bishop of Hertford, to celebrate the first Confirmation Service in St James's for 25 years. On that day, Bishop Michael also blessed the new Bells and Ringing Chamber – something watched on TV by the congregation below!

Events and socialising

The fairs throughout 2016 were very well attended.

Due to a generous donation, we hosted a Christmas lunch for our seniors. This was an immense success with good food, good company and some wonderful carol singing after lunch. Other events included quiz nights, barbecues and get-togethers in the Rectory garden on many occasions which are very much appreciated. We are thankful to Fr.Neil for allowing us to trample all over his garden.!

Several members of St James's went on the parish pilgrimage to Walsingham in October. They found this to be a wonderful experience and a further visit is planned on 2017.

Community work

Christmas Day 2016 saw our first Community Christmas Lunch. This was well attended, and we were heartened by the wider community's response for extra help and donations. We were most grateful for those, and look forward to this becoming an annual event, together with Soup and Chat also launching in the new year.

George Michael RIP

Following George Michaels untimely death on Christmas Day, St James's became the focus for the local community to pray and pay their respects to a local boy who went to Bushey Meads School. A large number of people came to pay their respects and sign the visitors book, many of them from outside Bushey.

Church House

During 2016 this was well used by a range of community groups and also for St James's and Parish events. At the end of 2016 negotiations took place to relocate Buzykidz nursery into Church House from Falconer Hall. We are delighted to welcome the nursery into Church House from the beginning of January 2017.

REPORT FOR ST. PAUL'S CHURCH 2016

St. Paul's congregation is blessed with a church that can easily be adapted to accommodate a variety of services, events and functions. The Sunday Sanctuary service (4th Sunday of the month) attracts a relatively small number but the service, usually held in the small chancel area, is peaceful and atmospheric and at 6.30pm is a great end/start to the week.

The Discussion Evensong service (1st Sunday of the month) is well-received and is attended by worshippers from all three churches in our Parish and by members of other neighbouring churches. We are grateful to our visiting preachers.

The 12.30 Eucharist service on Wednesdays is proving more popular than the previous mid-week evening service, regularly attracting between 9 and 18 worshippers. We're extremely thankful for the diversity and flexibility that our new monthly structure provides.

The St Pauls' Committee also chose to join with St James's in becoming an affiliated member of the Inclusive Church Network. This step publicly reinforces the welcome we extend to all our Community.

Five members of our congregation joined the Parish Pilgrimage to Walsingham in October, returning with an icon of St. Paul which is now prominently displayed in church.

The Wednesday Coffee & Chat mornings continue to be much appreciated by people seeking company, a few hours break from caring for a loved one or catching up with friends and we are pleased to report that we have been open EVERY Wednesday since its inception nearly 2 years ago!

St. Paul's remains proud of its charitable and fundraising activities and we are pleased to report another successful year.

A total of 8 Proms were organised during the year. Each concert raises a good sum for a nominated charity and we are very grateful to the performers - both amateur and professional - who offer their time and talents to give us these special events. Thanks also go to those who prepare the church and provide refreshments.

Our jumble sales continue to be blessed with both an incredible number of attendees and volunteers. The 7 sales raised around £2,600 in total and continue to provide items for our Christmas Fair and Wednesday 'bargain' table. The short prayer before the sale and the open 'manned' church (for which we thank Ann E White and Catherine Brant) commits our efforts to God and has become a welcome addition to sale days. The Christmas Fair raised just over £3,000 and we are thankful to friends and family for their help and support. Takings from the Toy Stall (around £116) were earmarked for Red Trust Bushey.

St. Paul's was able to donate \pounds 1,011 to Watford Mencap after what has become an annual event, the Charity Quiz and themed Supper Evening. A good-humoured evening was enjoyed by all and plans are well underway for this year's event.

A further £1,500 made up our end-of-year charity giving, spread between 10 diverse charities.

The John Stobbart Hall continues to be an excellent source of revenue as it is rented by the Nursery Bush-e-Babes every day and most Saturdays for parties.

St. Paul's strength lies in its congregation and for that we thank God. Of the (approximately 8) people who committed to St. Paul's by joining the electoral roll in the past few years, 7 are now on the 'jumble sale team', one serves on a committee, another regularly provides cakes for Wednesdays, 3 undertake minor maintenance and household tasks and, perhaps most pleasingly, 2 became confirmed and 5 joined either a Bible Study or Discipleship Course ! We feel truly blessed.

Our wonderful building takes on yet another role on a Monday afternoon, as Youth Worker, Joe Palfreyman writes :

'Our Youth project at St Paul's church has been steadily growing since its beginning. Youth work is a wonderful opportunity to become involved in the lives of our local young people and since January 2016 we have been giving out free Hot Chocolate to the young people walking home from school on a Monday. A few months in we were at a stage of relationship with a core group of 10 or so young people. We opened the doors of the church and equipped the building with games consoles, miniature ping pong & snooker and a plethora of craft activities. Since that point we see between 5 - 20 young people (depending on after school activities) come in and attend the

club alongside our team of leaders. On top of this we have the stream of between 50 - 75 young people who just briefly stop by to say hello and have a hot chocolate before heading home. Week in week out we have incredibly valuable discussions with those who stay for the 2 hours or so.

The team have the privilege of investing in the lives of these young people, getting to know them, giving advice, providing a safe place and an adult to talk to in a world that is difficult to understand. As of January 2017, intern Harry Gibbins took over the project as part of his university degree. Joe now takes a support role, encouraging, equipping and growing other projects elsewhere alongside Harry. 'Youth' as a Parish of Bushey project is currently having some graphic design work done and we hope to get posters, banners and flyers out to the local community as soon as possible so that all those who wish to can know about what we do. Our aim has always been that many young people in the Bushey area would come to see and know the love and kindness of Christ. Through our persistent service the youth of Bushey are seeing this in thought, word and deed. Prayer for the team and project are always appreciated'.

REPORT FOR HOLY TRINITY CHURCH 2016

This year at Holy Trinity has been a year of growth, which has meant North Bushey has been an exciting place to be around. We launched a new service near the being of the year called I Iam Life. The vision was to provide a more informal service with the format of worship, teaching and ministry. We started small with a group that could fit into Dave and Ann's lounge, but over the year, we have been privileged to have many people from all sorts of background join us.

It has been exciting to baptise people this year, whether infants or adults. Our full immersion baptisms being a real highlight for the Holy Trinity family. It was lovely to have Bishop Alan come to confirm a group of young adults whom as a church community we have watch grow and develop over the last couple of years.

There is nothing more exciting that discussing and praying with people as they explore the Christian faith. We ran the Alpha course for the first time in the Frying Squad café and it was a huge success. We want to say thank you to Jo who not only allowed us to use her café but also cooked and hosted everybody so well. The group that did Alpha together has gone on to become a Life Group where discipleship continues.

Our engagement with young people continues to grow. Joe and the youth team have continued to see the open youth group grow in size and depth of relationship. A highlight was taking the first ever group from our parish to Soul Survivor. The young people loved it and it is always a joy to see young people meeting Jesus. We ran our first youth Alpha this year and we now have more than 10 young people gathering every week to do a bible study, pray and worship together.

This autumn we started Messy Church on a Wednesday afternoon. We had no idea what to expect and with over 75 at our first service it was a huge success, but there were more people than we could handle. The team have since then been fasting and praying that we would have fewer people but deeper relationships. It could so easily be just another activity we put on but we long for it to be just like every other service at Holy Trinity as a moment when people whatever their age and background would 'Taste and see that the Lord is good'.

Fundraising socials continued through the year with again our now famous Burn's night supper being a huge success again. Quiz night, cream teas, murder mystery evening, just a minute to win it and barn dance were just some of the ways we have raised money and had fun at the same time.

Holy Trinity church had slightly lost its way recently. There are now signs of regeneration and growth happening all over the place. The foundation of Kingdom growth is always prayer and our week of 12/7 'Thy Kingdom Come' prayer was really significant. As a result, we look forward to creating a permanent place of prayer in 2017. This will fuel transformation of lives and to see Jesus Kingdom come on earth as it does in heaven.

Our reflection as we finish this snapshot of a year at Holy Trinity is to remind ourselves and to let you know of our purpose which is to be a place and a group of disciples that live out the invitation from Psalm 34 to 'Come, taste and see that the Lord is good'.

• **Tue. 4th Feb** ~ at All Saints, Leavesden, at which Tim Roberts, Senior Minister at Wellspring Church in Watford told us about the initial steps towards 'Continuous Prayer Response' and also spoke about the exciting ecumenical work of 'Christians Across Watford'.

• **Tue, 12th Apr** ~ at St John's Church, Sutton Road, Watford, in which Revd David Stevenson and Mrs Helen Langeveld (Headteacher), told us about the exciting progress of the new St John's C of E Primary School, opening in September 2016. † The post of Deanery Secretary has remained vacant since late 2014. Should you be interested in supporting this part of the church's work, Christine Cocks, amongst other Deanery Synod reps, has a copy of a 'flyer', with a brief job description of the unpaid post of Watford Deanery Synod Secretary. It's estimated that, along with eight meetings per year, it involves about 2-3 hours/month; access to a computer is essential.

Policies group.

Policies are a key part of any governance structure. Church life is no exception to this. They form the framework within which we work. As a growing organisation in terms of staff and activities it became apparent that we needed to adopt new policies to meet our growing needs. As an employer, we also need to have policies pertaining to our staff. The Policies Group was formed at the July meeting of the PCC.

The main remit of the group is to identify where a policy is required, to write a policy and to advise the PCC who then approves the Policy. The group will also review and amend polices at the review date. All policies now have a review date and there is a timetable in place to allow this to happen.

Policies are public documents and comments are welcome from all and will be considered by the policies group. This is a new group and there is a steep learning curve and we may not get it right first time. Polices do evolve over time with use and that is why we have a review date as part of the process and we welcome input from outside of the group. If you would like a copy of any of the policies at any time, please let me know.

Home Communions.

This is a very necessary and immensely privileged ministry. Lay and ordained ministers take preconsecrated hosts to the house-bound and to the residents of Bushey Beaumont. A shortened form of the communion service is provided as a guide. The leader will usually use the readings and collect set for the previous Sunday. Prayers and intercessions will then be offered; these will normally be personal to the household and also will events in the local community will be remembered. Some times a carer, partner, family member, friend or a friend from the church community will join in the service. This adds a particularly special dimension to the service as it becomes an extension of the worshipping body of the church.

The home communion team have maintained a schedule to those members of our community who have been unable to get to church for one reason or another. It may be due to an operation or illness or to increasing infirmity. The team have willingly visited and it is testament to their dedication that this is such a valued ministry by both the visitor and those who are visited.

Pastoral Visitors

The Pastoral visitors' team has tried to meet monthly. We now join the Eucharist at 10.15 am in St James's on the first Tuesday of the month; this gives the team the opportunity to meet with members of the Bushey Parish staff, wardens and clergy.

During our meetings we try to reflect on our visits and the different things, which we have learnt about ourselves and how we can maintain and improve our pastoral skills. We visit individuals at home or have a coffee in a local café or sometimes a visit may be a walk round the park. There is a great deal of informal support given to many members of the parish by many different people and we are grateful to them and to the Pastoral Visitors' team for the care and concern which is shown by everyone.

Group for Healing Prayer

The group has seen several developments during the past year which seem to be taking us on a new and wider path than before. There are now nine of us, and with these numbers we have been able to start offering prayer for healing at the 8.00am service at St James's once a month. We have changed the day of healing prayer at 9.30am to the first Sunday in the month, so as to offer opportunities for healing to a larger congregation, and in February seven people came up for prayer. This means seven people who were able to receive prayer when they needed it, including several who are not regular churchgoers. This is very encouraging, as it shows how prayer can be a vital resource in serving not only our congregation, but the wider community.

This was also clear at the Christmas Fair, when the members of the group wore sashes 'Here to Pray', and gave out leaflets inviting people to come for prayer for illness, anxiety, or depression. Many people during the course of the day came for prayer, about half of the number being from outside the church.

We are planning to change the healing service in Holy Week, to be a day when anyone can come into the church [Holy Trinity] to take part at various stations relating to healing, and to receive healing prayer if they wish. Leaflets publicising this will be given to mothers and carers at the group for toddlers, and also to the mothers of children who stop for hot chocolate, and in this way we hope to reach out with the love of God to the people around us.

We have found that our faith has deepened following these experiences, and that we are being led into new ways of prayer and encouraged to take new risks. We are growing in the confidence that prayer really is supernatural, and that many people around us are thirsting for the love of God to touch their lives.

Baptism Preparation

The Baptism Preparation Group took a slightly different form this year. Baptism Preparation introduces baptism candidates, their parents and god-parents to the concept and liturgy of baptism, its significance in the life of the child and its family and the role of godparents.

In 2016 baptism preparation sessions taken by the clergy, visiting the home of baptism candidates. During January to December 2016 there were twenty baptisms. In 2017, Baptism Preparation is now being held at 10am on the first Saturday of the month.

Bell Ringers' Report

No report was received.

St James's Church Choir Report

The choir has continued to support the regular and occasional services over the past year both by providing support with congregational singing and the singing of settings, motets and anthems.

We have had very successful weekend visits to York Minster and the Cathedral and Abbey Church of St Alban. On these occasions we deputise at the regular Saturday and Sunday for the Cathedral Choir who are on holiday.

Due to the competence and commitment of a relatively small number of regular singers we have continued to maintain an appropriate repertoire of music for the liturgy. We were delighted to welcome Roger Pragnell as a regular tenor in the choir.

Community Fair

Following on from the positive response to last year's North Bushey Community Fair, a similar group of local residents organised this year's superb event. Learning from and improving on last year's event, it was felt a bigger stage was needed for performers; toilet facilities and somewhere for tea and coffee refreshments were also required and the ability to raise charitable funds by running our own tombola and raffle were decided upon as key factors in this year's event. The committee of volunteers worked hard to raise funds, find prizes and pull together the exciting event, which saw approximately 700 people attending across the afternoon. The glorious sunshine and superb music all performed by local acts, gave a fantastic atmosphere to the green, and many families were seen sitting on the grass enjoying the event, even late into the afternoon. Just under £1000 was raised for and divided between our 3 nominated charities, Herts Air Ambulance, Groundwork East Green Aiders Scheme and Homestart Watford and Three Rivers.

The organising committee felt the need to extend the community spirit seen at the fair to another event later in the year and therefore worked together to organise the Carols on The Green in December, which saw approximately 200 people (a number far exceeding our expectations!) gathering around fire pits, drinking mulled wine and eating homemade mince pies, to listen to and join in with songs about Jesus' birth.

Both events are now firmly fixed in the calendar again for this coming year and we look forward to seeing more of the impact of God's presence in this community.

Red Trust Bushey

Little Reddings School

The Foodbank is due to open in January 2017, with the help of St James's in providing a venue and storage. We are gradually getting to know those who are in need of support in this area and are helped by local people from the community working alongside us. Little Reddings harvest assembly gave us a real boost to our supplies and Bushey Meads are currently collecting for the Foodbank.

The Red Cafe

We've loved starting our Saturday morning café at Little Reddings with help from different churches in Bushey. There's a great communal atmosphere with a wide cross section of people from the community and although confidentiality does not allow specifics, people have been able to share their needs in this context. We see this as a vital stage in building trusting relationships out of which we can run enquiry groups for those who are interested when the time is right.

<u>Bus</u>

We have been offered a converted double decker bus for use in our area. Amazingly the use of the bus would be gifted to us but we need to find funding for everyday running costs and maintenance. The bus would provide us with much needed space to develop other community projects including youth work, budgeting courses and greater freedom to offer a café to the community.

Youthwork in the Parish

St Pauls - From Crawling to walking

At the end of last year's report, I stated it was an exciting time for youth work in the parish. 2016 has not disappointed. We have seen God do wonderful things using our service to accomplish much for the Kingdom of God, as well as having a lot of fun with all the young people we interact with on a weekly basis. We rebranded the work we do across the parish to the straightforward and descriptive name of 'Youth'. Multiple projects, multiple locations all under the banner of 'Youth' in the Parish of Bushey

The new year saw the continuation of our second youth club project; the cold month of January being the perfect setting for free Hot Chocolates outside of St Pauls church, a church ideally located on the walk home for many of our local students.

A few months in, we were at a stage of relationship with a core group of 10 or so young people, which meant we could open the doors of the church and with a grant kindly donated by Hertsmere council, we equipped the building with games consoles, miniature ping pong & snooker and a plethora of craft activities. Since than point we have consistently seen between 5 and 20, young people (depending on after school activities) come in and attend the club alongside our team of leaders for the full 2-hour session. We are currently organising a trip out for this core group so that we might get to know them even better. On top of this, we have the stream of between 50 - 75 young people who just briefly pop into the building to say hello and have a hot chocolate before heading home.

Holy Trinity - From walking to running

The 'Youth' club at Holy Trinity has also evolved further. Being about 15 months older than the St Pauls project. In the spring - summer term, we ran a Youth Alpha course, where between 5-10 young people learnt what Christianity is all about. We have a depth of relationship with these young people that enables us to do more. Once Alpha was finished the young people asked us if there was anymore. Thus, the club evolved to meet their needs.

Friday night youth club is now followed by a 60 - 90 minute session we are calling 'Youth Church'. Where we look at Bible teaching, each session revolving round a key character from the bible. Learn lessons, ask tough questions and have open discussion.

The Queens School

Joe also now runs the Christian Union at The Queens School once a week. Running similar discussion based teaching. 2016 winter term was focussed on 'Heroes of the Old Testament'. The New Year will see us looking at the parables of Christ.

Soul Survivor Summer Festival

In the summer holidays, our team took a small group of pioneering young people to the Christian festival 'Soul Survivor'. We camped together, shared food and played games in our spare time. Then, twice a day, attended teaching and worship meetings. All the young people that went experienced something new of God. Encountering His love, kindness and healing power for themselves. It was a wonderful time; time put aside for God. We are currently planning the 2017 trip that approaches in August.

A privilege – The future

Week in week out we have incredibly valuable discussions with those young people who attend our programmes. The team have the privilege of investing in the lives of these young people, getting to know them, giving advice, being a safe place and adult to talk to in a world that is difficult to understand. As of 2017, Joe's brother is a professional graphic designer and we are getting some graphic design work done so that we can establish ourselves in the parish as a project for everyone, through Banners, posters, flyers and a website. Our aim has always been that many young people in the Bushey area would come to see and know the love and kindness of Christ, through our persistent service the youth of Bushey are seeing this is thought, word and deed. Prayer for the team and project are always appreciated.

2016 Reports Buildings and building for our future

Sustainability Implementation Group

In accordance with the decision of the PCC to proceed with the sale of two properties no longer essential to Parish requirements, work commenced to sell both Trinity House and Falconer Hall. The criteria for selling such properties was that the price achieved had to demonstrate satisfactory value in order to comply with the requirements of the Charities Act 2011 (s119). Trinity House was sold for £471k to a private buyer on the 24th March 2016. Marketing of Falconer Hall, which began on 10th May 2016, resulted in considerable interest but was interrupted by the decision of a local councillor to apply for the Hall to be listed as an Asset of Community Value (ACV). This was agreed by Hertsmere Borough Council on 14th September 2016. The purpose of the listing was to ensure that the local community would have the opportunity to bid for the Hall during a protected period. No such bid was forthcoming from Hall users, but a Jain faith charity active in the local community, Shrimad Rajchandra Mission Dharampur UK, entered a bid and this eventually resulted in a future date for the sale of the property in January 2017. The price achieved was the best offer available and reflected the very poor state of repair of the Hall and the high cost of renovation. With completion of this sale the

work of the Sustainability Group as currently constituted has been concluded. The considerable sums realised by the sales will greatly benefit the continued ministry of the Parish in the future.

Church House Management Group

The Church House Management Group was set up to take on responsibility for the day to day management of Church House. The group is made up of the Parish Wardens, and the St James's Deputy and Pro Wardens.

The group met a couple of times in 2016. It was then agreed that the business of the group become part of the fortnightly St James Wardens meeting. It made sense to incorporate it into the wardens meeting as it is the same group of people all of whom have constraints on their time. The group discusses and takes decisions on issues such as repairs, hall lets, cleaning, refuse disposal and ensuring that chairs and tables are in sufficient numbers for user's needs. This is a key role as it is important that Church House is managed and kept in good repair and clean for all hall users. With the increase in Community use of Church House this has become more important and if standards are not maintained could impact on our income stream. A big thank you to those who help in any way with the smooth running of Church House.

St James's Wardens

Buildings Group

The Buildings Committee continues to meet on the first Monday of every month and is made up of 2 members from each of the 3 churches. Its objective is to maintain the Parish buildings within a budget that is provided by the PCC.

Items on the Agenda are marked with a 'Q' for Quinquennial if appropriate and all other items fall into the Repairs/Maintenance/Improvements category. Each building is discussed in order, as it appears on the Agenda and, where action is to be taken, subsequent Minutes include the initials of the appropriate Committee Member.

Some of the work carried out during the year is listed below :

- St. James's Lime plastering to combat damp (Q) Repairs to tower staircase and tower door (Q) Repairs to roof guttering (Q) Replacement boiler
 Holy Trinity Turret and gutter repairs (Q)
 - Fitting of new dome
- St. Paul's Replacement of some windows (Q) Updating of Interior lighting (Q) Updating of exterior lighting

The halls have also had various minor items of maintenance and repair work carried out during the year.

Repairs and Maintenance is obviously ongoing but we have broken the back of the Quinquennial work which we have another 3 years to complete.

Problems with the buildings are usually reported by a member of the congregation or a tenant and 2 estimates are obtained by a member of the Committee. Sometimes, with emergency work, this is not possible but all work has to be agreed by members of the Committee. It has also been stressed that, before any final payment is made to a contractor, a member of the Committee must inspect the work.

Falconer Hall Management Group

Although formed at the APCM, this group did not meet – as the work of Sustainability Group impacted on Falconer Hall.

Parish Finance Officer's Report for 2016

This is my last report as Hon. Treasurer of Bushey Parish. I'd like to start by thanking the three Church Treasurers, Greg Batts, Mike Young and Gill Onslow for their service over the last year. I will continue to serve the parish by running the CMF and claiming the gift aid from the donations to the church and Greg, Mike and Gill have offered to continue to support the CMF (planned giving) from the three congregations. I'm pleased to say that Felicity Cox has agreed to take on the role of Hon. Parish Treasurer and I wish her well in her endeavours for the parish. I'd also like to thank Christine Cocks for her invaluable support in preparing the final accounts on behalf of the parish.

In 2016 the total receipts on unrestricted funds (excluding sums received from the sale of Trinity House) were £280k of which £137k was from unrestricted voluntary donations including gift aid. Restricted donations of £14k were also received. Total income in 2016 excluding the sale proceeds was £295k which was 11.1% Less than 2015's total income of £330k. Excluding the sale proceeds the net results for the year were a deficit of payments over income of £76k. This is a worrying situation for the parish. The parish once again paid its Parish Share to the diocese in full although the parish did not entirely meet the target set.

The sale of Trinity House was achieved in 2016 and this was to be utilized to engage in some outreach and mission projects, and also to be able to maintain three fit for purpose church buildings. We have already applied some \pounds 40k of this income and in total \pounds 110k of reserves, which has enabled some of the outreach projects listed in this report. It has also provided funds for some essential work at St James's replacing boilers together with other work at all three churches listed under the report of the buildings committee.

The sale of Falconer Hall has not yet been achieved although significant progress was made in 2016 and we hope this will be achieved early in 2017. Whilst this will boost our reserves continued application at the rate we have seen this year is not sustainable as reserves will be exhausted quickly and there are significant foreseeable buildings and fabrics expenditure for which these will be required.

We are already reviewing our costs and reducing these wherever we can. We also need to review our giving and encourage all who are on the electoral role or part of the church to join

our planned giving scheme (CMF) to try to improve our income. We will be having a full programme of renewal of our scheme in 2017 as is normal practice after three years and I hope all that can join or increase their giving will. We will also need to increase our fundraising across the parish both through both social activities and fellowship, and through identifying if possible individual or corporate sponsors of items, outreach or other projects.

At the direction of the PCC we will request the Charity Commission to endorse payments to Vicki Adamson (Church House cleaner) and Stuart Brant (Director of Music, St. James's) as these are both "connected persons" (that is they are married to a Charity Trustee/PCC member).

Notes to the Accounts for the Year ended 31 December 2016

The Parochial Church Council of the Ecclesiastical Parish of Bushey is a Parochial Church Council established under the Parochial Church Council Powers Measure (1956) as amended and the Church Representation Rules, and is a charity registered with the Charity Commission in England and Wales, number 1130540. Details of the principal office are included in the PCC's Annual Report.

The Parochial Church Council of the Ecclesiastical Parish of Bushey meets the definition of a Public Benefit Entity under FRS102.

I. Accounting Policies

The financial statements have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 16 July 2014 and Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102), the Church Accounting Regulations 2006 and Charities Act 2011.

The financial statements have been prepared under the historical cost convention except for the valuation of investment assets, which are shown at market value. The financial statements include all transactions, assets and liabilities for which the PCC is responsible in law. They do not include the accounts of church groups that owe their main affiliation to another body nor do they include groups that are informal gatherings of church members."

2. Funds

General funds represent the funds of the PCC that are not subject to any restrictions regarding their use and are available for application on the general purposes of the PCC. Funds designated for a particular purpose by the PCC are also unrestricted.

Restricted funds are those funds that must be spent on restricted purposes and details of the funds held and restrictions are provided in note 8. Endowment funds, where the capital must be retained, are also explained in note 8.

3. Incoming Resources

Voluntary income

Collections are recognized when received by or on behalf of the PCC. Planned giving receivable under Gift Aid is recognised only when received. Tax recoverable on Gift Aid donations is recognised when the donation is recognised. Grants and legacies to the PCC are accounted for as soon as the PCC is notified of its legal entitlement, the amount due is quantifiable and its ultimate receipt by the PCC is reasonably certain. Funds raised by fund raising events are accounted for gross.

Other income

Rental income from the letting of church premises is recognised when the rental is due.

Income from investments

Dividends are accounted for when due and payable. Interest entitlements are accounted for when receivable. Tax recoverable on such income is recognised in the same accounting year.

Gains and losses on investments

Realised gains or losses are recognised when investments are sold. Unrealised gains or losses are accounted for on revaluation of investments at 31 December.

4. Resources Used

Grants

Grants and donations are accounted for when paid over, or when awarded, if that award creates a binding obligation on the PCC.

Activities directly relating to the work of the Church

The Diocesan parish share is accounted for when due. Any parish share unpaid at 31 December is provided for in these accounts as an operational (though not a legal) liability and is shown as a creditor in the Balance Sheet. Costs of generating funds include the cost of stewardship campaigns, investment management costs and costs relating to rental properties. Charitable activities comprise the costs relating to the work of the parish. Governance costs represent the costs of running the PCC as a legal entity and include the costs of preparation and independent examination of the accounts.

5. Fixed assets

Consecrated property and movable church furnishings

Consecrated and beneficed property of any kind is excluded from the accounts by s10(2)(a) of the Charities Act 2011.

Movable church furnishings held by the Vicar and Churchwardens on special trust for the PCC, and which require a faculty for disposal, are accounted as inalienable property unless consecrated. They are listed in the church's Inventory which can be inspected at any reasonable time.

All expenditure incurred in the year on consecrated or beneficed buildings, or on individual items under $\pm 1,000$ is written off.

Land and buildings are shown at cost or at valuation based on 1970 figures.

Depreciation

Fixtures and Fittings are depreciated at 10% of cost and Office Equipment is depreciated at 25% of cost. Buildings are depreciated at 2%. However, since the 1970 valuations included the land it is assumed that each contributed 50% to the original valuation such that the effective depreciation is 1% as land does not depreciate.

6. Investments

Investments are valued at market value at 31 December.

7. Current assets

Amounts owing to the PCC at 31 December in respect of fees, rents or other income are shown as debtors less provision for amounts that may prove un-collectable. Short-term deposits include cash held on deposit either with the Central Board of Finance of the Church of England Funds or at the bank.

8. Liabilities

Liabilities are recognised when there is a legal or constructive obligation to expend resources.

9. First-time adoption of FRS 102

This is the first year that the PCC has presented its financial statements under FRS 102. The following disclosures are required in the year of transition. The last financial statements prepared under previous UK GAAP were for the year ended 31 December 2015 and the date of transition to FRS 102 was therefore I January 2014. As a consequence of adopting FRS 102, a number of accounting policies have changed to comply with those standards. The policies applied under the company's previous accounting framework are not materially different to FRS 102 and have not impacted on funds or net income/expenditure.

Church Workers Pension Fund (CWPF)

Bushey PCC (PB 2014) participates in the Pension Builder Scheme section of CWPF for lay staff. The Scheme is administered by the Church of England Pensions Board, which holds the assets of the schemes separately from those of the Employer and the other participating employers.

The Church Workers Pension Fund has a section known as the Defined Benefits Scheme, a deferred annuity section known as Pension Builder Classic and a cash balance section known as Pension Builder 2014.

Pension Builder Scheme

The Pension Builder Scheme of the Church Workers Pension Fund is made up of two sections, Pension Builder Classic and Pension Builder 2014, both of which are classed as defined benefit schemes.

Pension Builder Classic provides a pension for members for payment from retirement, accumulated from contributions paid and converted into a deferred annuity during employment based on terms set and reviewed by the Church of England Pensions Board from time to time. Bonuses may also be declared, depending upon the investment returns and other factors.

Pension Builder 2014 is a cash balance scheme that provides a lump sum that members use to provide benefits at retirement. Pension contributions are recorded in an account for each member. This account may have bonuses added by the Board before retirement. The bonuses depend on investment experience and other factors. There is no requirement for the Board to grant any bonuses. The account, plus any bonuses declared, is payable from members' Normal Pension Age.

There is no sub-division of assets between employers in each section of the Pension Builder Scheme. The scheme is considered to be a multi-employer scheme as described in Section 28 of FRS 102. This is because it is not possible to attribute the Pension Builder Scheme's assets and liabilities to specific employers and that contributions are accounted for as if the Scheme were a defined contribution scheme. The pensions costs charged to the SoFA in the year are contributions payable (2016: £2,746, 2015: £154).

A valuation of the scheme is carried out once every three years. The most recent scheme valuation completed was carried out as at 31 December 2013. This revealed, on the ongoing assumptions used, a surplus of £0.5m.

There is no requirement for deficit payments at the current time.

Pension Builder 2014 will be valued in relation to the lump sum payable to members at normal pension age. There are no annual pension benefits. Pension Builder 2014 commenced in February 2014 so the first full valuation of that section will be carried out at the next CWPF valuation date, 31 December 2016.

The principal funds of the parish are invested with the CBF (Central Board of Finance) or the SADBF (St Albans Diocesan Board of Finance) in the form of deposit funds from which interest accrues. These are included within the cash funds of the PCC (see below).

Investments constitute shares held with the CBF Investment Fund and for which dividends are received. As with such investments, the value of these shares fluctuates up and down, as do the dividends received. They are valued at the bid (sale) price on 31st December 2016.

INDEPENDENT EXAMINER'S REPORT TO THE PAROCHIAL CHURCH COUNCIL OF BUSHEY

I report on the accounts of the Parochial Church Council OF Bushey (PCC) for the year ended 31 December 2016 set out on pages 30-38.

RESPECTIVE RESPONSIBILITIES OF TRUSTEES AND INDEPENDENT EXAMINER

The PCC is responsible for the preparation of the accounts. The PCC consider that an audit is not required for this year (under section 144(2) of the Charities Act 2011 (the 2011 Act) and that an independent examination is needed. The charity's gross income exceeded £250,000 and I am qualified to undertake the examination by being a qualified member of The Institute of Chartered Accountants in England and Wales.

It is my responsibility to:

- examine the accounts under section 145 of the 2011 Act and in accordance with the Church Accounting Regulations 2006 (the Regulations);
- to follow the procedures laid down in the general Directions given by the Charity Commission under section 145(5)(b) of the 2011 Act and to be found in the Church guidance, 2006 edition; and
- to state whether particular matters have come to my attention.

BASIS OF INDEPENDENT EXAMINER'S STATEMENT

My examination was carried out in accordance with the General Directions given by the Charity Commission and to be found in the Church guidance, 2006 edition. An examination includes a review of the accounting records kept by the PCC and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeking explanations from you as trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on whether the accounts present a 'true and fair view' and the report is limited to those matters set out in the statement below.

INDEPENDENT EXAMINER'S STATEMENT

In connection with my examination, no matter has come to my attention:

(1) which gives me reasonable cause to believe that in any material respect the requirements:

- to keep proper accounting records in accordance with section 130 of the 2011 Act; and
