# Chairman's Report for 2023

I am delighted to present the annual report for the Parish of Bushey, covering the period of my tenure over the past seven months. It has been a time of immense joy and fulfilment as both Robin, and I have been warmly embraced by the parish community. Transitioning from central Watford to Bushey has offered us an opportunity to immerse ourselves in parish life here.

One of the most striking observations during this period has been the integral role played by St James and St Paul's in both the spiritual and everyday lives of the community. The deep connections fostered in these churches have highlighted the significance of our mission to nurture a vibrant and inclusive community rooted in the principles of love, forgiveness, and tolerance as taught by Jesus in the Gospels.

The established pattern of Divine Worship is our 10am Parish Mass on Sundays at St James and the 11:15am Sung Mass at St Paul's. Both have average to below average number attending, I have yet to establish why the significant decrease in attendance has occurred. Additionally, our midweek services, including the Wednesday 12:30pm Said Mass at St Paul's and the Thursday 11am Said Mass at St James, provide regular opportunities for spiritual engagement. The monthly Messy Church sessions at St Paul's have proven particularly popular, offering families a dynamic and creative encounter with God.

The occasional offices of baptisms, weddings, and funerals have begun to increase in frequency with the appointment of a Rector. We anticipate further growth in these sacred rites throughout 2024. A significant aspect of our ministry has been the pastoral care extended to families during times of loss, with the burial of ashes becoming a more frequent occurrence.

Despite a recent break in at St James just before Christmas (nothing stolen) our commitment to keep our churches open for private prayers remains an important part of our ministry. I'm pleased to report that St James continues to welcome visitors daily, being open weekdays 8 am to 6 pm.

As we reflect on our parish's strengths, four key areas of significant missional engagement have emerged:

- 1. **Open Buildings Engagement with the Community:** Our churches serve as open and inviting spaces for both churchgoers and non-churchgoers alike. The sense of community and belonging is palpable, fostering deep connections and mutual support. They are sacred places of meeting, prayer, and silence.
- 2. Bells are the Voice of the Church: The resonant peal of bells at St James and the single chiming bell at St Paul's serve as audible reminders of our presence and invitation to worship. These ancient bells resonate through the community, drawing people to the sacred space and reminding them that God dwells with them.

- 3. **Music is Praying Twice:** The musical offerings at both churches have the potential to reach hearts and minds, enriching our collective worship experience. Whether through traditional hymns or contemporary melodies, music plays a vital role in elevating our worship and fostering spiritual connection. Our parish has a proud musical heritage which is ripe for revival.
- 4. St James Grave and Churchyard God's Garden: The peace and beauty of St James's churchyard provides a tranquil retreat and is a buzzing home to a wide variety of biodiversity. Amidst the hustle and bustle of daily life, the churchyard offers a sacred space for reflection, prayer, and communion with nature. We have a responsibility to care for the mortal remains of those buried here, provide a home for God's creatures and creation and a place where our community can come and enjoy this place. This includes the Pond and Lych Gate areas.

Looking ahead, I am optimistic that these strengths, coupled with the insights gleaned from our upcoming Mission Action Plan (MAP), will fuel further growth and vitality in our parish community.

I would like to extend a heartfelt thanks to Salome, our church warden whose support has been invaluable to me throughout my settling in period. Again, thanks to her for the leadership she has given with the PCC and Committees during the vacancy.

To each member of the parish, I extend my sincere gratitude for all your ongoing commitment and contributions to the work of God in Bushey. Together, let us continue to shine as a beacon of hope and love in our community to the glory of God the eternal Holy Trinity.

The Parish of Bushey is a Registered Charity number 1130540 and has two churches.

St James's (the Parish Church) is situated in Bushey High Street, and St Paul's is situated in Bushey Hall Road (WD23 2EQ), Holy Trinity in Bushey Mill Lane (WD23 2AS) was closed in 2021.

The parish is part of the Diocese of St Albans within the Church of England.

Those wishing to be PCC members as well as PCC secretary, Treasurer or pro-wardens must stand for election in their own right. After serving on the PCC for three years, the previous parish policy for people to take a year off before standing again was repealed at the 2021 APCM, reverting to the default position specified in the Church Representation Rules 2020 which permits immediate re-election. The Hon Treasurer is co-opted onto the PCC.

Day to day management control of the churches is exercised by the Incumbent and the Churchwarden(s), contactable through the Parish Office, St James's Church House, High Street, Bushey, Hertfordshire, WD23 IBD, Telephone 020 8421 8192. During a vacancy, the Rural Dean has oversight of the Parish.

#### Structure, Management and Governance

The Parochial Church Council (PCC) is a corporate body established by the Church of England. The Ecclesiastical Parish of Bushey operates under the Parochial Church Council (Powers) Measure 1956.

The PCC is registered with the Charity Commission, number 1130540.

The method of appointment of PCC members is set out in the Church Representation Rules, 2020. All those who attend our services are encouraged to register on the Electoral Roll and to stand for election to the PCC. All members of the congregations can attend PCC meetings, but do not vote. PCC members receive information on trustee responsibilities, basic health and safety, risk management and safeguarding procedures.

The PCC held seven regular meetings with a number of decisions made under the "Business by Correspondence" provision of the Church Representation Rules 2020 and ratified at the next meeting.

Issues raised for discussion at PCC meetings included:

- Discernment process for the new Rector
- Safeguarding ensuring training and Dashboard up to date
- Long term repair of Church Tower.
- Managing Finances. Paying the Parish Share. Use of reserves.
- Future use of Holy Trinity building. Terms of Lease, funding of necessary works.

# Statement of Public Benefit

The Members of the PCC have referred to the guidance in the Charity Commission's general guidance on public benefit when reviewing the aims and objectives of the charity and in planning future activities. In particular the PCC considers how planned activities will contribute to the aims and objectives set.

The Parish of Bushey demonstrates public benefit with the following activities:

- > Regular public worship open to all
- > The provision of sacred space for personal prayer and contemplation.
- > Pastoral work, including visiting the sick, frail, and bereaved.
- > Teaching of Christianity through sermons, courses, and small groups.
- Promotion of the whole mission of the church through provision of activities for senior citizens, parents, toddlers, young people, and other special needs groups.
- > Teaching and discussion of Christian Ethics.
- Environmental/Ethical issues (unsold items recycled), supporting other charities in the UK and overseas.
- Community involvement, including the support of local cultural events (music, artistic, etc.) and social action Coffee & Chat, and providing space for the Red Trust Bushey foodbank.

#### **Objectives and Activities**

The Parochial Church Council (Powers) Measure 1956 states that the PCC: is to co-operate with the Minister in providing in the ecclesiastical parish the whole Mission of the Church, pastoral, evangelistic, social, and ecumenical.

In the Parish of Bushey, we continue to develop within the Diocesan Living God's Love programme which includes deepening spirituality, outreach to the local community, and a Mission Action Plan.

1. Achievements and Performance

Baptism and Marriage preparation provide opportunities for teaching, support and welcome to the church. Special Christmas services in each church welcome many families and schools to joyful celebration. A weekly "coffee, cake and chat" operates at St. Paul's which has been very well supported and some stay to share in the Eucharist afterwards.

Saturday lunchtime recitals and lunches at St James's. 'Messy Church', monthly at St. Paul's for everyone, but mostly young children, continues to thrive.

#### 2. Planning and development of fundraising activities

Well proven fundraising events-quiz nights, raffles, lunches, suppers, concerts and Christmas sales; all provide opportunities to assist with financial support for the parish, and assistance

to charities. They also have a social function and draw in members of the local community. A programme of lunchtime recitals were good occasions and successful 'fund-raisers' as well as drawing together the wider community.

3. Exploration of Eucharistic and Social Life in ways that lead to growth opportunities.

Special welcome services and Patronal Festivals and social events are joyful occasions and give opportunities to welcome members of other churches, and our local community.

4. Ecumenical links

The World Day of Prayer (originally Women's Day of Prayer) is supported within the Parish.

5. Links with other Faiths

Informal links are maintained with the Hertsmere Forum of Faith and Bushey Interfaith Forum.

# St. James's Church

We started the year with one final service from Rev Thomas Singh who had been helping us during the initial stages of our interregnum. For several months we were served by Rev Stephen Mepham on a regular basis with occasional visits from Fr Tayo Falope, until the appointment of our new Rector, Fr. David Stevenson. His induction at the beginning of July with a joyful and thankful congregation from across the parish saw the end of a disruptive period and the start of a new phase of our worship. We are still able to see Fr Tayo on occasions when Fr David celebrates at St Paul's.

During the year we celebrated three weddings and welcomed a new member to the church in a baptism. Sadly, there were three funerals, two of whom were much loved members of our regular congregation and another from a neighbouring parish with long term connections to our church. Three families buried ashes of loved ones in the Memorial Garden during the year.

Special occasions this year included being the primary location for the joint Churches World Day of Prayer and we were able to join in the celebrations of the coronation of the new King, Charles III, with a service and parish lunch. The Christmas events were well attended, especially the Carol service, two parish Christingle services in addition to two special school ones, and a final crib service on Christmas Eve.

We still do not have a regular choir or Director of Music but have welcomed a small selection of visiting organists to our services with the occasional said mass when no musician was available. On a number of occasions however a choir has been assembled to add to the service including a sung evensong and sometimes a Cantor visiting from Germany joins us.

Musical life is still a focus, and we had an extensive Recital programme during the year with piano, organ, violin and singing represented which helps bring the local community to the church.

Thanks to everyone who has helped us during the year both at worship and in the general preparation and maintenance of the church.

# St. Paul's Church

2023 started as 2022 had ended with a variety of priests officiating at our services. In January, we welcomed Fr. Tayo who became a more regular fixture during the year and later, in July, we were pleased to welcome Fr. David Stevenson as Rector of the Parish and look forward to a period of stability having been without a Rector for some time. Fr. Tayo ran a very interesting Parish Lent Course at St. Paul's, which was well-attended and in March tested a

Songs of Praise café-style Sunday service (certainly very different) where we were encouraged to talk about, and sing, our favourite hymns together.

Early in January St. Paul's hosted a quiz/curry evening in aid of the St. James's Bell Tower Fund, raising almost £1,000. It was Fr. Tayo's first experience of a British quiz! The annual Macmillan Coffee Morning in September was very well-attended and raised over £800 for Macmillan.

In November we were delighted to welcome Bishop Alan at St. Paul's to celebrate a Parish Eucharist with Fr. David who ensured the church looked splendid for the occasion.

Once again, we're grateful to friends and family who helped make the Christmas Fair such a success and it was a joy to have our Rector pray with us before the doors were opened. Around £3,200 was raised for Parish funds.

St. Paul's Wednesday morning Coffee & Chat, in its ninth year, continues to be a blessing for the whole community. We would love more people to stay for the short service which follows but, regardless, we feel that the Holy Spirit is at work during those few hours. The service regularly attracts around 8/9 worshippers although Ash Wednesday saw 24 packed into the small chancel area.

We also saw a packed church on Christmas Eve for the traditional Crib Service, led by Fr. Tayo.

We have much to be thankful for. We feel blessed to worship in a place that can easily be converted into a space for other activities whilst retaining the spiritual glow that the church provides.

We were rocked during the year to lose four loyal members of our congregation. However, as always, trusting firmly in God's plan for us and under our new Rector, we're confident that St. Paul's will flourish.

#### MESSY CHURCH AT ST. PAULS

Messy Church continued to take place on the third Wednesday of each month, followed by a planning meeting to decide on the next theme. Crafts are then available, the children have Celebration Time, led by our priest and the afternoon culminates in a shared meal. Both Fr. David and Fr. Tayo proved to be big hits with the children. Ten sessions were held during the year and attendance averaged 16 children/18 adults.

Messy Church struggled during the year, having lost the input of its leader due to health issues and then, in the Autumn, the sad and sudden loss of its very efficient administrator. They cannot be replaced. However, we feel blessed to have the invaluable help of volunteers, not only from our 2 churches, but from outside the Parish who freely give their time and considerable expertise to this most rewarding outreach into the community. We are always looking for volunteers.

# **Buildings Committee**

During 2023 we spent the first 6 months in a Vacancy when there was a freeze on spending, although Roy Golding managed to work on securing the future use of Holy Trinity. This involved a significant amount of time and costs dealing with professionals and the Diocese sorting out the lease. There were also a lot of items that needed new homes or selling if no longer required. We sold several social items, e.g. football table, table tennis table, bouncy castle and chairs to local community groups at a reasonable price and the proceeds went into Parish Funds. All religious artefacts were treated carefully and taken to St James for use or storage. Finally, a painting was boarded up with a protective wooden frame.

In September, the Margaret Howard Dance Studio opened, providing opportunities for the local community which is part of our Mission in Bushey. They signed a 10-year lease which will also bring in much needed funds for the Parish.

During the vacancy we could only undertake urgent repairs and the restoration of the Reredos at St James using part of Miss Fairfield's Legacy in Parish Reserves. However, once Fr David arrived in July and joined the Committee, we were able to focus on short term and longer-term work to maintain, repair and improve our buildings. We also learned that the PCC is now responsible for the Rectory adding further costs to our Buildings' Projects.

In addition to regular maintenance and volunteer repairs, some of the significant work carried out during 2023 totalled ~£19,000 and included:

- > New wiring and asbestos survey at Holy Trinity to meet tenancy requirements.
- Architect's Report on St James Tower/Church roof repairs preparing for significant work in 2024.
- > Electrical improvements in Church House with extra sockets and new Hall lighting.
- > Church House Flat improvements/redecorating to prepare for new tenants at a higher rental.
- > St James Tower Parapet Wall repair.
- > Repainting of North Porch and Lychgate at St James.
- > New lighting under the Lychgate and above the West Door at St James.

As Chairs, we are grateful for the Committee Members, Baz Butcher, Keith Durant, Martyn Lambert, Gill Onslow and not forgetting Fr David who joined us in July. We also wish to thank Len Richards who was part of our committee until the summer.

# Watford Deanery Synod

The Deanery meetings are an opportunity for representatives of all the Watford & Bushey Churches to get together and discuss common problems. After a prayer and reflection session the gathering is usually addressed by the Rural Dean, the Rev. Peter Waddell and other local Clergy, with questions and suggestions from the floor.

The first meeting in February was hosted by All Saints, Leavesden. Our speaker from Watford Food Bank was, unfortunately, unable to join us but we had a very interesting discussion among the churches present about how we can help support Food Banks and provide Outreach to the local Community in a time of rising food prices and big heating bills.

The June meeting was cancelled but we met again in October at St Peter's Church, Bushey Mill Lane.

Rev. Canon Tim Bull and Mrs Hilary Knight from the Abbey reported on St Alban's Cathedral Revisioning - a conversation in the Cathedral community and across the whole Diocese on Mission priorities for the next five years. They sought our ideas and comments in discussion groups around questions such as:

- > What is the purpose of the Cathedral and how much do we value it?
- What can the Cathedral do to support the Diocese and our shared commitment to Living God's Love?

I am still the sole representative of Bushey Parish on the Deanery Synod and would welcome anyone else who would be interested in joining me.

During the year we have had only two potential issues concerning people who were not members of St James Church but approached us for help. Our focus now must be to get our Dashboard up to date, which following Covid and the period without a Rector has been sadly neglected. This is now underway and will hopefully be addressed in the near future with the support of the PCC.

# **Church Membership Fund**

2023 was another difficult year for the CMF, with falling membership across the three historical communities. Obviously, this makes it even more difficult to meet our Parish Share – and even to pay a significant proportion of it out of regular giving, as is the recommendation. Unfortunately, excluding our clergy, there was no increase in the numbers in the Parish Giving Scheme (PGS) in 2022. At the close of the year there were 34 active members, compared with 51 during 2022. There were 17 (2022: 16) in the PGS and 17 (2022: 35) in our traditional CMF standing orders and envelopes spread across our 2 churches, embracing the three former communities.

Active CMF Members during 2023 are compared with previous years in the Table below. (Note these figures would not include clergy who have joined the PGS.) It is worth noting that one member could represent a partner or a whole family. It seems no longer appropriate to identify the contributions separately, by congregation. The continuing drop in active membership makes it increasingly difficult to sustain our ministry in the Parish and the vacancy – which we are glad is now over – is not something that usually attracts additional support. We also realise that everyone is facing huge increases in the cost of living; in that respect, the church is no different.

At the last APCM, there were 109 people on the electoral register (ER), and it would be wonderful to have support from those not currently in our CMF. It would be great to have more people on the ER join the CMF and pledge and donate a regular amount to the Parish, even in the current economic situation, such that we can at least maintain what we have left.

If you are a member of one of our churches and are not already in the CMF, please consider joining. You may contact either of the CMF Representatives below, or one of the clergy; we really need you. Any amount you can afford will be received gratefully and you can change the arrangement at any time, because you control your giving. The PGS arrangement means that the administration is removed as a burden to the parish: all the gift aid is dealt with and reclaimed promptly. Finally, if you are a taxpayer, if you pay tax above the basic rate, you can claim the difference between the rate you pay and basic rate on your donation\* and so reduce your personal tax bill – we claim the basic rate tax back at no cost to you! If you like to keep to the envelope system but don't want to pay weekly, we have a way of creating properly anonymous (numbered) labels with the frequency of dates that suits the giver (monthly, 4 weekly): just contact the CMF rep to get the information to me.

# St James's Bellringers

The Bushey ringers are delighted to welcome Fr. David Stevenson as Rector of the parish. Ringing has continued at St James' Bushey on Sundays, when enough of the band are available and on Thursday evenings throughout the year. Attendance at practices is variable but we do receive support from ringers of other towers.

2023 will be remembered as the year that we lost our dear friend and superb ringer Kath Baldwin. Kath was a faithful member of the Bushey band for over sixty years. It was pleasing that so many ringers attended her funeral.

In April 2023 Stuart Brant began his year of office as the president of the Hertford County Association of Change Ringers.

A lot of effort was put in to train 9 new ringers as part of the 'Ring for the King' campaign. Five rang on the day of the Coronation but only one of the nine continues to support ringing in the area.

The bells have been rung to mark important events throughout the year including:-

- > Friday 7<sup>th</sup> July 1280 Cambridge Surprise Major. Rung for Kath Baldwin's 91<sup>st</sup> birthday
- Wednesday 12<sup>th</sup> July 1260 Grandsire Triples rung for the collation and induction of Fr. David Stevenson as Rector of Bushey.

# Communications

#### PARISH WEBSITE; WWW.BUSHEYPARISH.ORG

The Parish Website is managed with "squarespace" and we pay about £200 annually for this important part of our communications within the Parish and out to the wider community.

During 2023 there were 12,589 visits to the website with noticeable peaks in July and December. The total is slightly less than 14,142 in 2022.

Analysis of the sections accessed (>1,000) for 2023 in descending order are:-

## St James's Churchyard

For the first 6 months Salome Jayaratnam managed churchyard issues in her role as Parish Warden, due to the Vacancy, supported by Jacq Birch. I am grateful for the continued support of Jacq fielding enquiries about new burials. This allows me to focus on dealing with the enquiries and requests from families about their relatives' grave across the various

sections. Peter Manhire has done a great job throughout 2023 keeping all the areas tidy; for most of the year on his own.

Since taking over in July quite a few enquiries have been handled for people trying to locate the graves of their relatives. Occasionally this is quite straightforward, although sometimes it can be time-consuming, but very rewarding when we get a positive result. In addition, I have been working with Hertsmere Borough Council (HBC) to understand who has responsibility for maintaining the different parts of the Churchyard which has been "Closed" since the 1960s. Two face-to-face meetings took place in the Churchyard with HBC's Cemeteries Manager who agreed that they would look after all the hedges, trees, paths and the grassed non-grave areas. It remains unclear who is responsible for the retaining walls. HBC promised to tackle the hedge by the Pond and lower it to improve visibility of the Church as part of 2023/24 Winter Maintenance.

During the year the Lychgate and North Porch were painted by volunteers and some new lights and signage erected.

Finally, we have tackled the requirements of the Bushey Churchyard and Trust Fund that has been in operation since 1997 when many small trust funds were consolidated along with the Ellis Grave Trust. There are 15 graves that the PCC are obligated to maintain by the terms of the Trusts. Beginning in the Autumn, a team of volunteers started cleaning and tidying these and by the year-end, 9 had been undertaken.

# **Christian Aid**

Our major fundraising effort for Christian Aid each year takes place during Christian Aid Week in May. We held our usual Parish Lunch, a few street collections and set up an e-envelope online donation route. Altogether we collected £520 + £50 gift aid.

However, this year we have had several requests for crisis funding and were able to respond positively to two of these appeals.

In March we held a special collection in both Churches for the Disasters Emergency Committee and Christian Aid Turkey & Syria Earthquake Appeal and collected over £200 at the morning services.

More recently, at the Christmas Eve Crib services in St James's and St Paul's we collected for the Middle East Crisis Appeal and were able to send almost £700 from Bushey Parish to this very troubled region.

Christian Aid is reliant on our generosity to help fund it's long term projects and crisis appeals and I thank you for your generous responses.

# 100 Club

The 100 club is fund raising activity, where any member of the parish plus any friends and family members can join in. Everyone pays £60 a year for each number, the payments are paid by a variety of methods to suit everyone's finances, standing order of £5 a month, £30 for 6 months or £60 for a year. We still accept payments by cheque and cash too.

The funds raised are divided between the prizes and the parish coffers. All who join can pick a number and on the last Friday of every month three numbers are drawn. - Luckily the number of participants has remained fairly consistent throughout the past year meaning the prize monies has remained the same. There are roughly 50 members. - Sadly a few members are no longer with us, but recently we have managed to recruit some new members too. The advert in the parish magazine is now nearer the front, and a full page, which I hope will attract more interest next year.

# Honorary Treasurer's Report 2023 and Accounts

The PCC's aim is to operate on a balanced budget basis; however, this is yet to be achieved as the Parish expenditure is still higher than Income. The Parish is still reliant on the use of reserves for major items of expenditure and payment of Parish Share

Overall, in 2023, total unrestricted expenses exceeded total unrestricted income by £43,056 an increased shortfall of £1,873 when compared to 2022 where the shortfall was £41,184.

#### Income

In 2023 the total receipts of unrestricted funds were £192,595 which was £3,911 higher than 2022 (£188,684).

Planned giving income was £45,301 which was £1,608 less than the £46,909 in 2022.

Income from Collections at services was £6,997 which was £1,861 more than £5,136 in 2022. It appears that the use of the digital sum up devices attributed to the increase.

Total Income from Sundry donations and appeals received - £5,063 (2022 -£6,469). This includes donations of £2,352 from coffee and chat mornings in St Paul's and £2,712 other donations.

Income received from Charitable activities was £28,053 which was £5,341 higher than 2022 (£22,712). The increase was mainly due to the additional income of £6,210 received for church lettings.

Income from Other trading activities was £85,391, which was £2,242 higher than the prior year (£83,149).

The income from hall lettings was £5,119 more compared to 2022, however the income for the Church house flat was £3,625 less as the flat was vacant for about two and half months. A new tenant has now moved in.

Buzykidz nursery ended the rental agreement for use of the hall gallery in October 2023, therefore regular rental income has reduced by £1,378 per month. There are proposals to find alternative hirers for the gallery.

Total income from fundraising events - £10,059 (£2022 - £9,311). Generated from Fairs & events - £4,585, Recitals - £2,344, 100 Club - £3,130. This includes income raised for Charities as follows : -

Macmillan coffee morning at St Paul's - £814, Ukraine Appeal -£ 292, Bishops Harvest £35. Children's Society -£ 100, Christian Aid £679, Military wives' choirs for Cross Stitch Challenge £158.

Dividends and interest from unrestricted funds received was £12,754, an increase of  $\pm$ 6,526 compared to £6,228.

#### Legacy Income

A balance of £68,271 is held for St James legacy funds, this includes JF Legacy funds.

#### Grant Income

A total grant income of £2,600 was received. £2,000 was received from St Albans Diocese for Warm space, £500 from Hertsmere council towards the Coronation celebrations (Tower bell event) and £100 for Messy church.

#### Expenditure

The total unrestricted expenditure in 2023 was £235,651 an increase of £5,783 on the prior year (£229,868). The total expenditure, including restricted expenditure in the year was £248,493 this was a decrease of £3,212 on £251,705 spent in 2022.

The following are attributable for the change in overall expenditure when compared to 2022:

- Parish Share £81,606 was £1,049 less than £82,655 in 2022.
- Church running expenses- utilities and waste collection £41,010. This represents an increase of £9,193 on prior year (£31,817)
- Maintenance & repairs Unrestricted expenditure was £12,108 a decrease of £22,575 compared to £34,683 expenditure in 2022. Maintenance and repairs expenditure are for electrical maintenance, boiler checks, organ tuning, alarm maintenance, building inspection fees, locks, and keys etc.
- Property Improvements £7,160 an increase of £5,621 on 2022.
- Upkeep of services £7,501 for wedding, funeral fees, and disbursements and other, consumables
- Administration & Parish Office salaries £18,926, £1,593 more than 2022.
- Church running costs of £13,331 within other costs is made up of Insurance costs £5,893, cleaning expenses £7,438. There is a cleaning contract for Church House.
- Music £8,348 was £2,658 less than 2022. The payments are for the Director of music and visiting organists. The contract with the Director of music ended in September.
- Independent examiner & accountancy fees £4,716

This left us with a shortfall of income to expenditure for unrestricted activities of £43,056 compared to £41,184 in 2022.

It is hoped that the shortfall here will continue to improve as more Income is received.

#### Holy Trinity Lease Rental

Holy Trinity Church is now leased to Margaret Howard Theatre. The lease commenced on the 4<sup>th</sup> of August 2023 for a period of 10 years. The Professional costs incurred with the lease agreement was £13,445 and £4,295 for repairs and maintenance.

Please see the tables below which summarise the Parish income and expenditure for 2023.

#### Parish Share

The Parish share for 2023 of £81,606 was fully paid. £49,596 was paid from draw down from Reserves to pay the Parish share.

In 2023 planned-giving including tax recovered of £56,838 represented 70% of the Parish Share. The PCC will need to consider a refresh of the stewardship campaign to increase planned giving donations to a level where they meet the parish share.

#### Reserves

The PCC applied for a total of £54,826 from Trinity House reserves in 2023.

£49,596 was used towards the payment of Parish Share. The balance of £5,230 will be used for maintenance and repairs in 2024. The Trinity House reserves has been fully drawn down and the CBF account closed as the balance is nil.

The PCC continues to endeavor to control expenditure tightly and increase income and cease utilizing reserves for running costs, to remain a going concern.

The PCC is grateful for the incredible generosity of many of all our congregations who, through their giving and donations, have met the cost of ministry and enabled the Parish to serve the community.

We pray that we continue to develop a financially sustainable parish which can go forward in strength to meet the future needs of the Parish.

#### Funds

Endowment funds comprise monies to be retained as permanent capital and invested to generate income.

Restricted funds are those where a specific limitation has been placed on the use of the capital or income by the terms of the bequest or donation.

Unrestricted funds represent monies to be used at the discretion of the PCC Designated funds represent unrestricted funds set aside for specific purposes by the PCC.

Details of Parish Funds are as follows:-

#### **Endowment Funds**

The Bushey Church and Churchyard Trust Fund	Monies held for the upkeep of the Churchyard. The capital is invested in CBF Investment Funds. Income is restricted to upkeep of the Churchyard.
Ellis Bequest (Grave Trust)	Monies held for the upkeep of the Ellis Grave. The capital is invested in CBF Investment Funds. Income is restricted to upkeep of the Ellis Grave.

#### **Restricted Funds**

Miss F M Mitchell Bequest	Monies given for the general purposes of St Paul's and invested in CBF Deposit Funds. Income generated is used to cover the running costs of St Paul's.
The Bushey Church and Churchyard Trust Fund	Investment income generated by the Endowment Fund above. Accumulated income is invested in CBF Deposit Funds.
Ellis Bequest (Grave Trust)	Investment income generated by the Endowment Fund above. Accumulated income is invested in CBF Deposit Funds.
Legacy	Monies given for the general purposes of Holy Trinity and invested in CBF Deposit Funds. Income generated is used to cover the running costs of Holy Trinity
Joan Fairfield Legacy funds (included in St James Legacy funds)	Monies given for the general purposes of St James - (£68,271)

#### **Unrestricted Funds**

Designated Funds

Capital Reserve

Capital reserves were created to recognise the properties under the control of the Parochial Church Council. The original reserves represent either the net cost or the valuations of the properties. Each year the reserves have been reduced by depreciation.

Church Fabric Fund	Monies set aside to provide for the maintenance of the church fabrics. Monies at the year-end are invested in CBF Investment Funds and Deposit Funds. PCC approved for Trinity House proceeds balance to be transferred to the Church Fabric Fund. The Trinity house reserves have been fully withdrawn and the CBF account will be closed.
Falconer Hall Proceeds	In line with the 2015 results of the Sustainability Review, carried out at the request in March 2015 of the PCC, Falconer Hall was sold early in 2017, because the costs of repair were prohibitive. The sale of Falconer Hall would help us to: • enhance existing youth work at St. James's •enable greater income generation possibilities through the provision of enhanced facilities at St. James's in due course, thus enabling us to develop St. James's more as a community focus for arts and crafts
General Fund	These represent unrestricted monies at the disposal of the PCC.
SJ Deposit	The SJ Deposit account was recognised in account balances last year but is a reserve deposit for use at St James only.
Parish Deposit	These represent unrestricted monies at the disposal of the PCC and reserves drawn down prior to use, the remainder is general income earning interest. The funds for the tower bell appeal are held in this account.
